BEER DONATION REQUEST FORM

Thank you for thinking of serving Castle Danger at your event! Castle Danger Brewing Co. (CDB) is happy to work with non-profit groups & fundraisers by donating beer. CDB will determine which donation type (on-site sampling, kegs/cans, etc.) best fit the event and request. Donations must be used for fundraising only. By completing this form, you are confirming that your group will have the proper liquor,/event licensing, insurance & staff required by the governmental agencies where your event will take place properly in place for the event. Please complete the form below and submit via email or mail, along with any event flyers if available, for your request to be considered. Please note there is no guarantee your submitted request will be approved. Incomplete or illegible forms will be immediately declined. We appreciate your understanding that we cannot make exceptions to our rules, as they are a combination of state laws and policies we share with our distributors.

THREE CRITERIA FOR BEER DONATION REQUESTS:

1. Non-Profit Status of Benefiting Organization

- Beer will only be donated to a non-profit or to an event benefitting a non-profit.

2. Liquor License

Select one of these two liquor license options, based on the event location:

- Event at a licensed bar or restaurant
- If the event is held at a licensed bar or restaurant, the beer donation will go through that license
- Event being held elsewhere
- A copy of the event liquor license must be included with the application
 - The organization must obtain an event liquor license (temporary on-sale license through city or county) or use a caterer's license

3. Proceeds to a Non-Profit

- By checking this box you agree that the Beer Donation, if approved, will be used solely to provide a direct benefit your organization. Any unused beer will be picked up by CDB within 5 days of the event.

CDB is unable to donate beer when it will be resold and the revenue collected from those sales provides a benefit outside of your organization.

If you meet these three criteria, please complete the next page and return it to CDB no later than two weeks prior to your event.
